South Asian wedding guidelines when using an outside caterer:

- The hotel will advise the Client of the appropriate space for the mendhi, sangeet, marriage ceremony, luncheon, dinner/dance and any other events you may be holding with us.
- The Client will work directly with a Hotel approved outside caterer for food, equipment and any additional items that require special handling. The Hotel must approve the outside Caterer, if they have not previously worked with us.
- Caterer must provide proof of insurance with a minimum liability of \$1 million. They must also provide a current operating license and food handlers permit, and sign a separate food waiver with the hotel.
- The Hotel has the final right of approval on all vendors hired who are not on the Hotel's Recommended Vendor List. The vendor must provide a current proof of valid liability insurance and a minimum of two current (within the past twelve months) letters of recommendation from similar establishments.
- Client will need to provide printed menu cards to read: "Cuisine prepared by (name of caterer)"
- Upon agreement of the date and policies
 - The Catering Agreement will be drafted
 - Signed Catering Agreement to be returned to hotel by specified decision date
 - 25% deposit based upon estimated minimum hotel charges is due with signed contract
 - Final payment of estimated hotel charges is due 30 days prior to the event date, payable by check or credit card.
- Client to provide confirmation of approved caterer 90 days prior to the event.
- Client orders food and pays approved caterer directly.
- Client provides caterer a guaranteed number of guests consistent with number of guests provided to hotel.
- Final Event Order outlining set-up, services and event timeline to be completed 14 days prior to event. Final guest count is due to the hotel no later than three business days prior to the event.
- All alcoholic beverages must be purchased from the hotel and served by hotel staff.

- Upholstered banquet chairs and 6' round dining tables for guest seating
- Floor length linen, white napkins
- Bernardaud Limoges fine bone china, hotel stemware and flatware
- Three votive candles per table to accent client-provided centerpiece
- Dance floor and staging for band, entertainment or head table
- Cocktail tables, guestbook table, gift table, cake table, DJ table
- Buffet tables with silver chaffing dishes
- Serving platters, vessels and appropriate utensils
- Access to a staging area for the outside approved caterer
- Use of the hotel's Kawai baby grand piano for 6th Floor events

Confirmation of Space & Deposits

Space may be confirmed on a definite basis as early as 18 months in advance. All dates are considered definite upon receipt of deposit and signed contract. A non-refundable deposit of 25% of the food and beverage minimum and a signed credit card authorization will be due upon signature of the contract. Two additional deposits are due 60 days and 30 days prior to the event, and are based upon the remainder of the food and beverage minimum plus sales tax, 16% service charge, and 8% administrative fee, and ceremony fee (if applicable). Full prepayment of all estimated charges is due no later 14 business days prior to the event date if paying by personal check, or three business days prior if paying by certified check or credit card.

Parking

The Four Seasons agrees to offer special event valet parking at a rate of \$12 per car during the hours of the event, or \$48 per car/per night for overnight valet parking. Self parking is available in the Lumiere Place Casino garage and will be charged at prevailing rates. The hotel does not control pricing or availability for the self parking garage.

Ceremony

The Four Seasons St. Louis offers indoor and outdoor options for your wedding ceremony. The hotel will provide chairs, staging, and wireless microphone included in the outside catering fee.

**An additional \$2500 rental fee will be charged for use of the 8th Floor Catering Terrace.

Guarantees

The guaranteed number of guests attending the event is due three business days prior to the event, no later than 12 noon. Once the guarantee is given, it may not be reduced. You will be charged either the guarantee or the actual number of attendees, whichever is greater.

Food and Beverage Minimums

Our Catering Manager will advise you of the food and beverage minimum based on the banquet space and requirements for your specific event. Food and beverage minimums are exclusive of service charge, room rental/ceremony fee, and applicable sales tax.

Beverage Policies

The sale and service of alcoholic beverages is regulated by the Missouri State Liquor Commission, and Four Seasons St. Louis is responsible for the administration of those regulations. It is the hotel's policy that all alcoholic beverages must be provided by the hotel.
